Definition

Disclaimer Clause

CONDITIONS OF INCLUSION

Inclusion of information and advertising supplied by organisations, associations, covens, musicians, businesses, groups, bands, authors, artists etc will be only considered if the following criteria are met. This statement will be deemed point #1 of "Conditions of Inclusion".

CRITERIA:

- All and Any participants who wish to be involved MUST ensure that cross-promotion takes place whether this be banner exchange or by other means of promoting The Cosmic Cauldron Network. Failure to include cross-promotion is grounds for breach of contract and will result in the works being removed without further consultation. This is deemed point #2
- All and Any Commercial promotions MUST be paid for at a nominated and negotiated price one week prior to the promotion being published or broadcast. This is deemed point #3.
- No offensive material or material pertaining to lewd misconduct WILL be published or broadcast. This includes pornography of any kind, offensive political propaganda and music or songs with offensive language. Any songs which have the word F**k in it more than once or twice will not be broadcast. This decision is at the owner's discretion. This is deemed point #4
- Contributors and publishers MUST ensure that any artwork, writing, video or music supplied are the intellectual property of the supplier or the supplier has licence and or copyright approval from the original artist, author or musician to act as a third party on their behalf.
- The Management of CCN will not be held responsible or accountable for any infringement of copyright by a contributor and legal action WILL be taken against the supplier of any material which may bring the owner and Network into disrepute. This
